Notes:

Due to the Rural Health Clinic (RHC) status for Welia Health Pine City and Welia Health Hinckley Clinics, Medicare and Medicaid pay cost-based, all inclusive rates per visits regardless of level. These rates change periodically based on estimated cost. As of January 1, 2023, the per-visit rates are as follows:

The Minnesota Legislature passed a law that requires certain clinics to report amounts for their 25 most frequent services that cost more than \$25. The services listed here do not reflect all of the services provided at this clinic.
